





Contractual Considerations

Purpose

The purpose of all exhibits is to inform meeting participants of the types and nature of the products displayed related to scientific, medical and information visualization and to provide information and explanation concerning related products and services. Appropriate product demonstrations and visuals can be used towards the stated purpose.

Space Assignments

The following rules and regulations governing the exhibit under the auspices of the IEEE Visualization 2007 Conference are part of the application for space and constitute a contract between the Exhibitor and the Conference. They have been formulated in the best interest of the Exhibitor and full cooperation of the Exhibitor in their observance is asked. Any detail not specified is subject to decision by the Chairpersons of the Conference (see page 5). Each assignment of space also entails benefits from the conference. The actual nature of the benefits depends on the support purchased by the Exhibitor (see Sponsorship Levels). Space will be assigned when the exhibitor has registered and returns a duly completed application along with the payment. Registration can be completed on-line as described on the conference web page pertinent to exhibitors.

Exhibit space will be assigned based on the date the application is received

The Exhibitor agrees to accept the space assigned. The application, along with full payment for space, should be returned to April Coles by **Wednesday**, **August 15**, **2007**. Exhibitors can send the application to April Coles (address above). The Conference reserves the right to modify the designated exhibit space in the event a change in the original assignment is necessary.

Badges and Staffing

Exhibitors should be able to access their registrations from the conference web pages. A confirmation electronic mail containing this information will be sent once the submitted application is processed. Names of appropriate staff at the exhibit can be added as needed. Each exhibiting company is limited to five (5) complimentary exhibitor badges. This will give exhibit staff access to the exhibit area only. Any exhibit staff wishing to attend the conference technical program must also register for the conference at the regular registration fee. Exhibits should be staffed during show hours. Identification badges may be picked up at the registration desk. Badge exchange between exhibitor representatives is not permissible.

Contract for Facilities

The acceptance of the application by the IEEE Visualization 2007 Conference and the full payment for rental charges constitute a contract. A completed application for space with full payment and all requested information must be submitted by mail or facsimile. Also, a high-resolution corporate logo is needed. Facsimile applications will be received but must be followed by payment by check. **Telephone requests will not be honored.**

Space Selections

Depending on support purchased, exhibitors will be provided one, two or three exhibition units. An exhibition unit is considered to be 8 feet by 10 feet, and 2 exhibition units are considered to be 20 feet by 8 feet. Other configurations are possible. Contact the Exhibits Chairs (page 5) for special needs. For each exhibition unit, the Conference will furnish a 6' x 30" table and two chairs. Exhibitors will be provided normal access to electrical power, and the internet as available at the hotel. In essence, all ordinary PCs and workstations can be supported with available internet connectivity. The exhibitors should make their own arrangements with the hotel staff for needs and requirements that exceed the minimum.



Terms of Payment

Full payment **MUST** accompany the application for space. No application will be processed without remittance of full payment.

Complimentary Registrations

Complimentary registration forms for the exhibitors that have that benefit included will be sent to the exhibitor after the registration is duly completed.

Cancellations

Exhibitors are requested to notify the Exhibits Chairs with cancellations. Cancellations are not effective until they have been submitted in writing to the Exhibits Chairs. The date the Exhibitor's written notice of cancellation is received will be the official cancellation date. Space reductions are considered cancellations and are subject to cancellation fees. It is understood that the Visualization 2007 Conference reserves the right, at its option, to reassign a cancelled space regardless of the cancellation rate assessed.

Refunds

Cancellation of space after *Friday, August 24, 2007* will result in **NO REFUND**. Cancellations between August 15, 2007 and August 24, 2007 will result in a partial refund of 50% of the original cost. Cancellations before August 15, 2007 will be charged a \$50 processing fee, but otherwise refunded in full.

Failure to Occupy Space

Any Exhibitor failing to occupy space is not relieved of the obligation to pay full rental price for space. The Conference shall have the right to use exhibit space as it sees fit, provided the space is not occupied by the scheduled exhibit hall opening, unless prior alternative arrangements have been agreed upon.

Sharing Space

Subletting of space is not permitted.

Operation of Exhibits

The management reserves the right to restrict exhibits which, because of sound, method of operation, materials, content or any other reason are deemed objectionable, and also to prohibit or evict any exhibit as a whole.

Size of Exhibits

Exhibits must be arranged so as not to obstruct the view or otherwise interfere with the displays of other Exhibitors. This restriction includes person(s), things, conduct, printed material, noise, or anything that may be objectionable to the exhibit as a whole. In the event of such restriction or eviction, the IEEE Visualization Conference or the IEEE Computer Society is not liable for any refunds, rentals or other exhibit expenses.

Exhibitors are advised and encouraged to carry insurance to cover their property against damage and loss and public liability insurance for claims of injury to the person and property of others.

Limitation of Liability

Exhibitor agrees with IEEE that IEEE shall not be liable for any damage or liability of any kind or for any damage or injury to persons or property during the term of this agreement, from any cause whatsoever by reason of use, occupation and enjoyment of exhibit space by Exhibitor or any person thereon with the consent of Exhibitor and that Exhibitor will indemnify and hold harm less IEEE from all liability whatsoever, on account of such damage, or injury, whether or not caused by negligence of or breach of an obligation by Exhibitor or its employees or representative.

Catastrophe
